Supervisor Steve Mascho asked if it was necessary to hire a P/T – as needed office clerk for just a few weeks when the billing clerk is out on vacation; Township Secretary, Susan Gibiser stated "Yes" since when it's a whole week, I'm not able to get my work done because I'm consistently doing the billing clerk's job of answering the phone, waiting on residents that come in the office, taking care of dumpsters and many other job duties.

- Discussion and Update on the status of Delinquent Garbage / Sewer Accounts

The Total amount of delinquent Garbage / Sewer accounts as of 12/31/2021 is **<u>\$214,297.00</u>**; This includes Municipal Liens that will be filed on nine (9) properties at the end of February in amount of \$22,719.00

The Board discussed the concerns of the delinquent garbage / sewer accounts and stated that the procedure of collections will need to be reviewed and updated since the delinquent accounts are getting out of control.

 Motion was made by Steve Mascho to approve the SALDO plans for St. Bernards Cemetery Assoc. for a 3-Lot SD to the property along the West side of West Washington Street; All of these will be sold & combined with additional lots; plans were reviewed & recommended by the PC at their meeting held on Wednesday, February 9, 2022

- Discussion concerning the update for the use of the ARPA funds: The U.S. Dept. of the Treasury has released the final rule for the use of ARP funds which takes effect 4/1/2022, however, local government agencies may take advantage of the new rules immediately.
 - 1) Total amount of funds received: \$ 239,849.50
 - 2) Total funds spent: \$ 89,962.84 (BTVFC, Gen Fund Reimbursed; PPE, account checks)
 - 3) Funds committed: \$ 65,996.60 (Compact Excavator)
 - 4) Remaining Funds: \$ 149,974.37 (includes interest)

The U.S. Dept. of the Treasury has released the final rule for the use of ARPA funds which takes effect 4/1/2022, however, local government agencies may take advantage of the new rules immediately; Roads / Bridges expenses have been added to the list of uses.

The Board discussed the options concerning the final ruling for the use of the ARPA funds and stated since the funds can now be used for Roads / Bridge projects and equipment, it would be better to use the Township's sewer funds for any sewer projects and or equipment.

 Motion was made by Laree Sue Behan to <u>not</u> use ARPA funds for the Wagner Ave Sewer project due to the changes in the final rules of uses; this project to be paid out of the Sewer Capital Reserve fund.

Public Participation

Dave Geitner asked the Board if the plowing on Crookerhouse can be cleaned up on the left side of the road going down Langmaid Lane; some snow is blocking the fire hydrant; asked Dan Burkhouse if the water flows are checked on the fire hydrants? Dan stated yes, the City Water Authority checks all hydrants.

Bob Burrell commented on obtaining grants for roads / bridge projects; stated the BOS should increase to five (5) members then it would not always be a 2 to 1 vote on issues. Steve Pettinato asked a question concerning Heil Bartlett

Jen Eakin stated she only saw the township plow truck once during the last snow storm Dave Debolt stated the fire hydrants on Delwood, Applewood and Peach were buried by snow from the plow drivers
