#### **NEW BUSINESS**

- Bradford Township did receive the 2<sup>nd</sup> allocation of ARPA funds in late
   September in the amount of \$240,607.84; also received additional ARPA funds in the amount of \$758.34; total amount received \$241,366.18
- During the 2023 budget work session on October 26<sup>th</sup>, the Board of Supervisors discussed purchasing the 2021 John Deere 524 4WD Loader using ARPA and Sewer funds if the Township doesn't receive the grant funds from the DCED Statewide Local Shared Assessment grant. Notification of the awarding of the grant funds will be on November 15, 2022. The BOS stated to the Secretary do a "Call-out Vote" to each Supervisor get their vote to proceed or not to proceed with the purchase of the Loader.

 On Thursday, October 27<sup>th</sup>, the Township Secretary did a "Call-Out Vote" to each Supervisor and asked the following:
