Steve Mascho stated he spoke with Kimberly Yeake from DEP about storm drains, berms and road maintenance, then proceeded to hand out copies of information to residents he received from DEP that pertains to road maintenance for berms and storm drains using a grader machine and stated the Township is not doing road maintenance and should be and not building bridges; the other Board members stated the Road crew does do these types of road maintenance for berms, storm drains and they clean out ditches along the roads, not on private property.
